

Fairfield Westchester PHA Chapter Minutes  
May 22, 2017

The meeting of the FWPHA Chapter was called to order at Coker Farm by President Fred Schauder. There were 8 members in attendance.

Prior to the start of the meeting there was a presentation by Kirsten Schuitema from the Princeton Equestrian League. Kirsten explained that her boss Andrew Philbrick has started a high score program much like FWPHA's program in New Jersey and would like our shows to offer their program at our shows for points toward their finals. Their program is much like Marshall & Sterling's point system and includes division from leadline to Grand Prix's. The PEL high score program can be offered at rated and non-rated shows and the cost is \$25 a person to join and \$25 per show for show management. The PEL finals are held from October 11-15<sup>th</sup> and you only need 30 points to qualify for their finals. The members thank Kirsten for her presentation and would consider offering the program to the FWPHA members.

Gary Gauruder read the minutes from the April 2017 meeting which were accepted as read.

Naomi Gauruder read the treasurer report from April 18, 2017 to May 22, 2017 which were accepted as read. Naomi stated that a CD that was due has been cashed out and the floor wants to contact Phil Richter to see if he has any ideas to reinvest this CD to get a higher percent of investment.

The award's winner will be chosen in the fall and the recipient would receive a trophy and a cash reward that would be matched by the National PHA. Any donations from chapters or the public would be recorded by the treasurer.
